#### ELECTION OF OFFICERS AND EXECUTIVE COMMITTEE MEMBERS

The Executive Committee of the BAHS consists of the Officers of the Society, the Editors of the *Agricultural History Review*, and 12 Ordinary Members. The EC membership is detailed on the enclosed list. The President is elected by the AGM for a three year period. The Chairman of the EC is elected by the members of the EC for a three year period. The Treasurer, Secretary and Editor(s) of the *Agricultural History Review* retire (and may stand for re-election) at each AGM. Ordinary Members are elected at the AGM to serve for a term of four years. They may not serve for more than two consecutive terms of office (i.e., eight years) without a break.

Two ordinary members of the EC, Professor Alun Howkins and Dr Paul Warde, are due to retire and are not eligible for re-election. One ordinary members of the EC, Dr Carl Griffin has served one four-year term and is eligible for re-election. There is one seat free on the EC as not all places were filled at the 2016 AGM.

Nominations are therefore sought for the posts of Treasurer, Secretary, and Editors of the *Agricultural History Review*, and for **three** ordinary members.

Nominations, with the signed consent of the nominee, must be received by the Secretary by March  $24^{th}$  2017. Proposers will be asked to submit a brief statement (about 20 words) about their candidates for the EC at the AGM.
