ELECTION OF OFFICERS AND EXECUTIVE COMMITTEE MEMBERS

The Executive Committee of the BAHS consists of the Officers of the Society, the Editors of the *Agricultural History Review*, and 12 Ordinary Members. The EC membership is detailed on the enclosed list. The President is elected by the AGM for a three year period. The Chairman of the EC is elected by the members of the EC for a three year period.
